

Level 3 Communications Ethernet / EVS Promotion

Terms and Conditions

Promotional orders must be received between May 3rd and July 30th 2010. Promotion applies to all Level 3 Communications® business groups and all sales channels. Customers will be eligible to receive 1 free month per 12 month contract, 2 free months per 24 month contract, 3 free months per 36 month contract and 5 free months per 60 month contract. Customers will begin receiving credit on the first full month of billing/invoice. Bill credits will be applied at the account level.
